**LARWOOD SCHOOL – BEHAVIOUR MANAGEMENT CONSEQUENCES LADDER  
PROCEDURE**

<b>TYPE OF BEHAVIOUR</b>	<b>POSSIBLE CONSEQUENCES</b>
<b>LEAVING SUPERVISION AT PLAYTIME</b>	<ul style="list-style-type: none"> <li>• No off site (Friday) activities for the week</li> <li>• Reflection and Indoor play</li> <li>• Repeat offender-removal of outdoor play on a Monday as soon as it happens (for the rest of that week)</li> <li>• Specific escorting around the building if level requires</li> </ul>
<b>LEAVING SUPERVISION AT LUNCHTIME</b>	<ul style="list-style-type: none"> <li>• As above but removal of (nearest) outside play which could be the next morning play</li> <li>• Specific escorting/ supervision around the building if level requires</li> </ul>
<b>LEAVING CLASS WITHOUT PERMISSION</b>	<ul style="list-style-type: none"> <li>• Class teacher “catch up” – Indoor play</li> </ul>
<b>REFUSAL TO WORK</b>	<ul style="list-style-type: none"> <li>• Class teacher “catch up session” to complete any outstanding work and then return to play</li> <li>• Repeat offenders may have Thursday after school detention for work completion – arranged by teacher with parent in advance and recorded on behaviour watch</li> </ul>
<b>DAMAGE TO PROPERTY</b>	<ul style="list-style-type: none"> <li>• Class teacher detention to make good damage</li> <li>• Where possible reflected in personal allowance</li> <li>• Restriction of use of damaged items where appropriate e.g.: only use laptop or iPad under supervision in class, not using for recreation etc.</li> <li>• Bill sent home</li> <li>• Close supervision around building or higher level of observation in class</li> <li>• Any serious damage to be recorded as an incident on Behaviour watch</li> </ul>
<b>VIOLENCE TO ADULTS OR PUPILS</b>	<ul style="list-style-type: none"> <li>• No off-site activity on Friday of that week</li> <li>• Event reflected in personal allowance</li> <li>• Magnolia based immediately after the incident. If it is at the end of the day, the individual will start off in Magnolia at the start of the next day. The time spent in Magnolia will depend on the severity of the incident and agreed by SLT</li> <li>• Repeated behaviour – referral to Police</li> </ul>

**MAGNOLIA**

- Offences of fighting, serious damage to property, absconding off site or violence to others (students or staff) results in a period of time in Magnolia (relative to the offence and agreed by SLT)
- One off excessive incidents should be brought to the attention of SLT so they can determine if an internal or external exclusion is required

Please note that due to the current Covid pandemic (refer to behaviour policy) we are offering limited local off-site activities and off-site restrictions will be replaced with in class supervision sessions
